It was also resolved that in future the Action Taken Report should be taken as an Agenda Item No-2.


- a) During the discussion of the action taken report of Agenda No-4 of the 7th meeting, it was resolved that the work of construction of Buildings should be got completed by the concerned agency within the stipulated times so that the cost of the building construction should not increase & extra financial burden may be avoided. XEN of the University should be directed to get the works completed in time as well as within the sanctioned budget of that work.
- b) It was resolved that keeping in view the shortage of staff in P.W.D. (B&R) & to avoid the delay in the construction work of Sports Stadium, the Police Housing Corporation be approached by the XEN of the University through Director, General Higher Education to take up the work of the construction of the Sports Stadium on priority and speedily.

2. To consider & approve the income and expenditure for the financial year 2014-15

The Finance Committee considered and approved the income and expenditure for the financial year 2014-15.

3. To consider & approve the Revised Budget of the university for the year 2014-15 and budget proposals for the financial year 2015-16

- a) The agenda was discussed in detail. The revised estimates and the budget was approved with the condition that a grant of Rs. 39.00 crores provided in the budget for the year 2015-16 is sufficient to meet their recurring and non recurring expenditure projected in the budget.

- b) Keeping in view the growth of the University over the next five years, the University will prepare a capital expenditure plan and the same should be got approved from the Executive Council of the University and, thereafter, be sent to the State Govt. for approval.
- c) It was also resolved that the proposals for the Regular posts of the teachers be got approved from the Executive Council as per work load of each & every deptt./institution & thereafter be sent to the Govt. for approval. To enhance the quality of education the Finance Committee emphasized that regular appointments be made instead of Teaching Assistants. All the efforts should be made to curtail the number of Teaching Assistants by minimizing the number of optional papers, wherever possible.
- d) Keeping in view the location of the University, it was also decided that the university should prepare a plan regarding construction of residences for teaching staff to enable the faculty to stay on the campus so that they can be engaged in various academic & extra-curricular activities of students. After getting the plan approved by the Executive council, it may be sent to the State Govt. for approval.
- e) The University should develop its ayurveda pharmacy products ^{so that} like Chavanprash etc. could be produced ~~so as~~ to enhance the income of the University, and Herbal Park of the University should be further developed in this regard. These efforts will go a long way to establish the contribution of the University for the society and the community at large.

SECTION – I

THE UNIVERSITY

Genesis

Today's Bhagat Phool Singh Mahila Vishwavidyalaya is the 'dream come true' of Bhagat Phool Singh Ji (1885-1942) who established a *Gurukul* for girls at Khanpur Kalan in 1936. After the demise of Bhagat Phool Singh, his equally dynamic daughter Subhashini not only took control of *Gurukul* but worked vigorously in expanding the *Gurukul* in terms of its various constituent institutions like BPS Memorial Girls' College (1967), BPS College of Education (1968), MSM Ayurvedic College (1973), BPS Mahila Polytechnic (1984), TIG Bhainswal Kalan (1999) and PSD Girls' Law College (2003).

The State Government upgraded the erstwhile *Gurukul* to the status of a University exclusively for women in August 2006 and christened it as Bhagat Phool Singh Mahila Vishwavidyalaya, which happens to be the first State Women University of North India. Since then BPSMV has undergone a complete transformation; a 75 years old *Gurukul* started with only three girls has turned into a modern university with approximately 6500 girls on its rolls studying in various job oriented programmes from KG to Ph.D level. The university has established its two regional centres at Kharal (Jind) and Lulla Ahir (Rewari).

Unique Centers

Centre for Indic-Asian Studies (CIAS): BPSMV is the first and only university in Haryana to be awarded prestigious Area Study Centre on Indic Asian Studies of UGC which carry out research on issues related to Indo-Asian knowledge systems. CIAS has operationalized its dedicated participative website www.sthaneshwaranidhi.ac.in which contains information on various themes pertaining to Indo-Asian culture and traditions. The Centre offers Certificate and Diploma programmes in Indian History and Sanskrit.

Centre for Society University Interface and Research (CSUIR): CSUIR was established in August 2010 with an aim to bridge the disconnection between University and society. It organizes courses and activities which are of direct relevance to the rural community and to formulate schemes that recover traditional good agricultural practices and sustain and conserve the vast knowledge reservoir of rural women. The Centre offers innovative courses in three core areas viz. Integrated Energy Resource Management, Microfinance Practices and Folk Medicine.

Academic Staff College (ASC): ASC at BPSMV is one of the premier Academic Staff Colleges of India offering faculty development programmes to in-service college and university teachers and administrators. It organized 05 refresher courses, 04 orientation courses, 02 workshops and 02 summer schools during the last year. So far 1251 participants have attended various programmes organized by the ASC.
