BPSMV POLICY ON ENVIRONMENT

PREAMBLE

Established in 2006, Bhagat Phool Singh Women University is the first State Women University in North India providing education from KG to PhD level, and has earned the place of 'University with a Difference' in the arena of Higher Education. The campus of the

Bhagat Phool Singh Mahila Vishwavidyalaya (BPSMV) is spread over lush green, pollution-free 200 Hectares of Land and 5600 girl students are presently on its roll. University is imparting education in all major streams like arts, sciences and social sciences. Besides that, BPSMV established center of excellence viz. Centre for Indic Asian Studies, Centre for Society University interface and Research, Learning Resource Centre. Moreover, university has Human Resource Development Centre.

An Environmental Policy is commitment of deed to control of pollution, conservation of natural resources and biodiversity along with environmental protection. India's National Environmental Policy (NEP) commits for pollution free and clean environment as per Article 48A and 51A (g) of Indian constitution. India is one of the countries in the world which has provision for protection of the environment in its constitution. The humanity is facing various environmental issues throughout the world and to overcome the environmental issues promotion of environmental literacy is a most important and viable solution. The Environmental literacy is the most important and simple way to aware the people about environmental issues. Being the temple of education, BPSMV believes that it has duty to inculcate the environmental consciousness among the students and society through outreach activities and can play a crucial role to tackle these issues and sustainable development by sharing knowledge. In brief, it is outlines that BPSMV manages its resources and also adopts environment friendly measures to contribute in sustainable development and project a role model for sustainable development in the society locally and globally.

OBJECTIVES OF THE POLICY

In nut shell the principles and objectives of the environment policy of BPSMV shall be:

- 1. Ensure that none of the activities at university campus severely harm the any component of the environment. It entails minimum negative environmental impacts, conservation and careful use of resources, due regard to biodiversity.
- 2. Ensure safe and pollution free environment for university community by promoting environmental awareness and consciousness among university community.

- 3. Sensitize the university community about negative effects of their lifestyle and action on the environment and ecology and how their changed attitude, acts and actions may preserve the resources and improves the environment for sustainable future.
- 4. Ensuring the implementation of applicable environmental rules and regulations and developing environmental auditing process as per university requirement and organizing various environmental activities to aware the society.

IMPLEMENTATION OF THE POLICY

Execution of Environment Policy will be carried out through:


- Eco Affairs Committee will be established which consist of students, administrative staff and academicians from various departments of the university.
- Provision of budget to carry out the various activities and proper implementation of the policy.
- The job of Eco Affairs Committee shall be to:
 - (i) Meet the objectives as listed above various kinds of programmes will be developed and recommended. The participation of society shall be encouraged.
 - Set up the task groups to design and suggest the programmes for execution of objectives and to monitor the progress.

- (iii) Consulting experts from academia (within and outside the university), industry and non-governmental organizations, as per need and requirement to achieve the various objectives.
- (iv) Reviewing the policy regularly for update and incorporation new ideas. The policy is to be reviewed every five years.
- (v) Hold the appropriate audit i.e. energy, environment and green audit to check the performance.
- (vi) Organize workshop, training and educational programmes to aware the university community about this policy and their role in implementation.
- (vii) Preparing proposal to seek financial aids from national and international agencies.
- (viii) Devise and advertise the list of Do's and Don'ts environmental activities.
- (ix) Publish annual report presenting initiatives taken to achieve the objectives along with identifying the issue need immediate concern.
- (x) Make available information and best practices to the university community and people through university website.
- (xi) Be liable to supervise, analyze and execution of the environment policy in true sense.
- (xii) Accountability of students, university fraternity and administrative staff as per assigned duties to manage environmental issues. Each and every one has specific duty for implementation of this policy in area of their control.
- The university shall appoint an Eco Affairs Officer for coordinating the activities pertaining to the implementation of policy.
- The Eco Affairs Officer shall act as Secretary of the Eco Affairs Committee.
- The complaints and suggestions received from university community regarding environmental issues at the campus shall review and necessary steps shall take to resolve the same with best suitable option.
- The appropriate departments/branches deemed to be suitable by the university authority, shall be required to provide their action plans to accomplish the objectives of the policy.
- Preparation of separate E-waste and Solid Waste Management Policy with due course of time.
