**Sub:- Making State Funded Universities self reliant**

Greetings from Haryana State Higher Education Council

In a meeting with Vice Chancellors of State Funded Universities chaired by Hon'ble CM on 09.08.2021, a number of issues pertaining to management of Universities were discussed.

The issue regarding augmentation of resources through various measures for the all round development of Universities also came up for discussion. It was suggested that the Universities need to invest a lot for campus/faculty development, introduction of high tech courses, up-gradation of labs, student facilities etc.. Therefore for attaining greater autonomy, the Universities need to generate resources through various means such as revision of fee structure, especially job oriented courses, roping in alumni for financial support, CSR funding etc. etc. and reducing dependence solely on Govt. Grant.

It is hoped that the University might have initiated the process in this regard and will share with the Council the roadmap for next five years depicting the increase in generation of resources through other means and gradual reduction in Govt. grant.
