


To consider and approve the recommendations of the Selection Committee meeting held on 27.12.2021 for the appointment to the post of Assistant Professor purely on contractual basis in Kayachikitsa (01) and Dravyaguna Vigyan (01- against leave vacancy) in MSM Institute of Ayurveda as per the must requirement of CCIM Guidelines to avoid de-affiliation/de-recognition.

Statement of the case –

Two posts of Assistant Professors were lying vacant in the MSM Institute of Ayurveda w.e.f. August and September, 2021 respectively. **As per CCIM Guidelines vide Para-7 "Vacancies arising out of retirement, Resignations or transfers etc either Govt. or private shall be filled by the institution within 90 days from the date of vacancy of the post or before 31st December of every year whichever is earlier under intimation to the Council"** (Annexure-I). Accordingly, 02 posts of Assistant Professor in the subject (01 – Kayachikitsa for one year) and (01- Dravyaguna Vigyan against leave vacancy, till the existence of the leave vacancy or one year whichever is earlier) for MSM Institute of Ayurveda were advertised vide advertisement dated 25.11.2021 and corrigendum 07/12/2021 (Annexure-II) to engage the Assistant Professor. Interview of the said posts was conducted in the office of Vice-Chancellor, BPSMV, Khanpur Kalan on 27.12.2021 at 11:00 A.M. onwards under the Convenership of Hon'ble Vice Chancellor. The recommendations of the selection committee are placed in the sealed envelope.

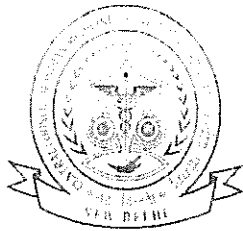

Subject: Revised guidelines for appointment and relieving of teachers from recognized/approved Ayurveda, Siddha and Unani Colleges -regarding.

The following guidelines to Ayurveda, Siddha & Unani colleges are issued in order to streamline the transfer of teaching faculty from one Ayurveda/Siddha/Unani College to another and also to avoid duplicity (same teacher to more than one college in same academic session):

1. Each faculty on the day of inspection of particular academic session will be considered as staff for that academic session for the same Ayurveda/Siddha/Unani Colleges only.
 2. Faculty shall not be considered the member of teaching staff of any college if he/she has been shown in the faculty list of more than one Ayurveda/Siddha/Unani Colleges during the inspection in the same academic year.
 3. All the faculties of Ayurveda, Siddha & Unani colleges in the country have to furnish their declaration on notarized affidavits countersigned by the Principal of the concerned institution and he/she shall be responsible for all the information furnished by him/her.
 4. Transfer/Deputation from one college to another college under same state Govt. shall be allowed as per state rule however, CCIM must be informed about such transfers and deputations.
 5. The appointing authority of the college shall accept the resignation of teacher according to the prevailing recruitment rules/conditions as specified in appointment order issued to the teacher at the time of appointment. If indicated with proper reasons like an opportunity in state Govt./Central Govt. or any valid reasons have:
 - Teachers willing to move to his native/reserve place of working.
 - Reasons of Health Grounds.
 - Teacher willing to join other institutions/colleges.
 - Such resignations shall be considered by the college and a copy (hard & soft) of resignation and relieving shall be forwarded to the Central Council of Indian Medicine for information.
 6. Once the requirement of rules and regulations are fulfilled in respect of resignation the college should issue relieving letter along with experience certificate to the concerned teacher within a period not more than 15 days.
 7. Vacancies arising out of Retirement, Resignations or transfers etc. either Govt. or Private shall be filed by the institution within 90 days from the date of vacancy of the post or before 31st December of every year whichever is earlier under intimation to the CCIM.
 8. The institution/college shall inform about the appointment of the new teacher to the Council of Indian Medicine within a period not more than 15 days.

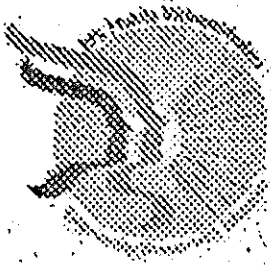

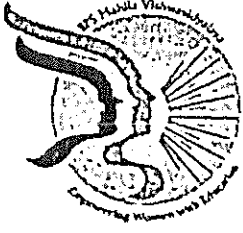
