Bhagat Phool Singh Ji (1885-1942)

Born on February 24, 1885 at Mahra Village in Sonepat District, Bhagat Phool Singh was a visionary noble soul. His firm belief in empowerment and emancipation of women through education led Bhagat Phool Singh to establish a Gurukul for girls at Khanpur Kalan in 1936. The anti-social elements did not appreciate the idea of women's education leading to Bhagat PhoolSingh's martyrdom on August 14, 1942.



Subhashini Devi (1914-2003)

Bhagat Phool Singh's legacy and philosophy was continued by his daughter Subhashini. She established various present day constituent Institutes of Bhagat Phool Singh Mahila Vishwavidyalaya through philanthropic means. The Government of India recognized her services to society and conferred the title of Padamshri on Subhashini in 1976.

The following words of educationist Annie Besant reflect my vision and mission for BPSMV:



The seed of today's Bhagat Phool Singh Mahila Vishwavidyalaya (BPSMV) was sown way back in the year 1936. The journey began with the establishment of a Girls' Gurukul with three girls in the first batch at Khanpur Kalan by revered Bhagat Phool Singh Ji whose seminal idea of empowering women through education was a revolutionary progressive giant step. The idea in fact could be termed as a precursor to today's 'Beti Bachao Beti Padhao' campaign. The erstwhile Gurukul established purely through philanthropic means not only expanded but also became a sought after centre of higher learning and education for girls. Bhagat Phool Singh Ji's vision and the hard work done by his daughter Padam Shri Subhashini turned the Gurukul into a premier institution modeled on Indian values and ethos.

It was in August 2006, the Government of Haryana thought of giving a firm shape to the idea conceived by Bhagat Phool Singh Ji and upgraded the Gurukul and its constituent institutions to a women's university mandated to further the original idea of Bhagat Phool Singh ji; "Women Empowerment Through Education". Since then BPSMV has expanded on all fronts and offers a range of academic job oriented programmes touching almost all aspects of life and career. Establishment of University's two Regional Centres at Kharal (Jind) and Krishan Nagar (Rewari) and affiliation of 06 women colleges with BPSMV is the testimony of its commitment and growing stature. BPSMV enjoys the distinction of being a university practicing 'University Society Interface' through community engagement, which is its core strength.



Salient Features

- BPSMV is spread over lush green, pollution free and serene campus of 400 acres and has its roots in ancient Gurukul system.
- The University is the first rural, multi faculty, residential and affiliating State Women University in the country.
- The University is well connected by road to NH1, Rohtak, Sonepat, Panipat and Delhi.
- The University offers completely safe and secure ambience for students.
- The University has established state-of-the-art language laboratory (LRC).
- The University trains school and college teachers of English through its autonomous Staff Training and Research Institute for Teaching of English (STRITE).
- All academic & examination reforms recommended by UGC like Semester System, Credit System and Continuous & Internal evaluation have been implemented. The University has initiated to implement Choice Based Credit System in all its academic programmes.
- It is the first University to establish a Centre for Society University Interface and Research (CSUIR).
- BPSMV offers facility to join NSS and NCC units.
- In order to offer skills' development opportunities to University girls and rural women from neighboring villages, Hero Motocorp in collaboration with UNDP has established Driving School on the University Campus.
- In order to provide entrepreneurship opportunities, UNDP has established Centre for Skills Development in Stitching at BPSMV for University students and rural women from the nearby villages.
- The University provides placement assistance to the meritorious students especially of the professional programmes. The companies are invited to the campus for placement.

Special Centers & Facilities

Centre for Society University Interface and Research (CSUIR): CSUIR was established in August 2010 with an aim to bridge the disconnection between University and society. It organizes courses and activities which are of direct relevance to the rural community and to formulate schemes that recover traditional good agricultural practices, sustain and conserve the vast knowledge reservoir of rural women.

University Placement and Counseling Cell (UPACC): UPACC provides free placement and counseling guidance to all the students of the University.

University Centre for Competitive Examinations (UCCE): UCCE imparts coaching and guidance to students of the University/affiliated and maintained colleges and other educational institutions for various competitive examinations and also prepare them to face interviews and improve communication skills.

Human Resource Development Centre (HRDC): The HRDC at BPSMV is the youngest & only centre in the country established in a women's university for organizing capacity building programmes benefitting thousands of teachers from across the nation. It is committed to provide quality programmes for development of teachers through effective & creative ways of learning. It has persistently endeavored to benefit the teachers & Nation through its programmes on both indigenous knowledge systems and contemporary pedagogical tools and technologies. The HRDC organizes Faculty Induction Programmes, Gurudakshta Programmes, Refresher Courses, Short term Courses and Workshops. The centre has conducted more than 150 Faculty Development Programmes benefitting more than 4800 teachers.

Front Line Demonstration Centre (FLDC): Based on Indo Israel project, FLDC of excellence in vegetables has been established by BPSMV in 03 acres. The centre trains farmers and women of neighboring villages in modern techniques of farming which in turn boosts their economic independence.

Learning Resource Centre (LRC): The Learning Resource Centre has six state-of-the-art Language Labs, equipped with latest technological software, which helps in effective learning of communication skills which are compulsory to learn for all the enrolled students. LRC imparts training & guidance for appearing in International English Proficiency examination Business English Certificate (BEC). The LRC had the privilege of hosting American interns.

Staff Training and Research Institute for Teaching of English (STRITE): STRITE has been established as an autonomous Institute of BPSMV for imparting training in effective teaching of English & operation of language laboratory to school & college teachers. So far STRITE hasconducted 10 Teacher Training Programmes.

Central Library: The Central Library was established in 2006. Spread over 9150 square feet area, it functions as the primary information resources centre and electronic resources for Teaching and Research central activities at the BPSMV. With a total collection of 128822 Books, the library also subscribes to 36 Periodicals/Magazines and 17 Newspapers in Hindi & English. The Reading hall has the capacity of around 100 readers. The Central Library provides the Computer Lab facility with wifi facility to its user to access the e-resources. Ever since its inception, the library has been growing in collection of Books, Research reports, Thesis & Dissertations, Reference works, Dictionaries, Encyclopedias and so on. Many knowledge-based services like Reference service, Reprography service, Databases, Internet Browsing and E-services are also provided by the Central Library apart from contributing to E-Shodh Ganga Repository and E-Shodh Sindhu for e-resources. It has access to many National and International Journals, Newspapers (Hindi & English). The Library provides access to reputed Database like DELNET and ISID, Journals like JSTOR, Economic & Political Weekly (E&PW), NDL E-Resources (World E-Book Library, SAA) and Urkund/Drillbit Plagiarism Detection Software through UGC INFLIBNET.

Established in the year 2007, the Department of English is one of the first University Teaching Departments (UTDs) created to offer qualitative and affordable programmes in English Studies. Driven by Indian grammarian and philosopher Bhartrhari's (570AD) statement scanned phrase that we take cognizance of the world through words, the department of English endeavors to evolve and strengthen the aesthetic, literary and linguistic understanding of life through literature and language. The key objective is to enable the enrolled students and scholars to become critical thinkers, proficient users of English language rooted in native culture and literary traditions. The Department is equipped with decent infrastructure and digital technology facilitating effective teaching learning ambience. The students are provided with a rich stock of books, magazines, newspapers and journals in the Department's library, reading room and networked computer facility. Besides academic rigor, the students are given adequate opportunity to participate in literary debates and discussions, presentations, sports, cultural activities and educational excursions & tours, conferences and workshops. As a special facility, the students are given an opportunity to learn and earn certificates in German, French and Russian languages. In order to improve communication skills of listening, reading, speaking and writing, the students are made to attend special classes in the university's Language Laboratory, which is one of the best in the region. The Department trains, assists and guides its students for securing placements in areas like teaching, public relations, call centers, technical writing, journalism, interpretation, translation etc.

Brief Introduction

The Department of Foreign Languages has been established in the year 2007 with an objective of enabling the students to learn and acquaint with modern foreign languages and cultures of the world. Foreign language learning improves the intellectual capabilities of the students as people who speak two languages have more grey matter in the language region of the brain; the earlier they learned the language, the larger the grey area (Mechelli et al., 2004). A language represents the 'thought' of a culture (Humboldt) and learning a language allows one to come into contact with the 'thought' and culture of another society. Globalization and economic liberalization (India, 1991) increased the demand for foreign language experts dramatically. Currently the department designs and offers courses at various levels in three foreign languages; French, German and Russian.

In the event of quota reserved for Physically Handicapped remain un-utilized due to non- availability for suitable category of Handicapped Candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%). Further, 3% reservation is also provided to Ex-servicemen/ Freedom Fighters and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block- B of Backward Classes category is concerned year wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in academic year 2018, the next Block i.e., (B) Block of Category of Backward Classes will be given seats in the next academic year 2019 and so on. Further, a roster register for reservation of seats for ex-servicemen/freedom fighters shall be maintained and carry forward all fractions, till one at is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided.

Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the Appendix-B1.

Where a seat is set aside for candidate from the deprived Scheduled Castes for admission in Government Educational Institution is not filled up in any academic year due to non-availability of candidate of the deprived Scheduled Castes possessing the requisite qualification, the same shall be made available to the candidate of Schedule Castes.

GUIDELINES FOR RESERVATION

- 1. The reservation of seats is as per the Reservation Policy of Haryana Govt. and is subject to change/amendment made by the State Govt. from time to time.
- 2. Candidates belonging to SC/DSC/ST are required to submit a certificate from the competent authority as per **Appendix-A**. The list of Scheduled Castes notified by the Haryana Government is available at **Appendix-B**.
- 3. Candidates belonging to Backward Classes are required to submit a certificate from the competent authority as per **Appendix-C.** Circular no. 1170-SW (1)-95 dated 07.06.1995 & No.213-SW (1)-2010 dated 31.08.2010, No.22/22/20043 GS-III dated 14.06.2016 and Haryana Government Welfare of Schedule Castes and Backward Classes Department Notification No. 1282-SW (1) dated 28.08.2018 and Notification No. 491-SW(I)-2021 Dated 17.11.2021 regarding criteria for exclusion of persons within the backward classes as creamy layer may be followed. The list of Backward Classes in Haryana notified by the Haryana Government is available at **Appendix-D**.
- **4.** The children or grand children (Maternal & Paternal) of Freedom Fighters are required to submit a certificate from the competent authority.
- 5. Only those candidates who have permanent disability of not less than 40% (being otherwise fit for admission to the program) will be considered for admission as Physically Handicapped. They will submit a certificate from the competent authority Appendix-M. Disability Certificate shall, however, be subject to verification by a Medical Board to be constituted by the University. The decision of Medical Board in this regard shall be final.
- 6. Children or Wards of Military Personnel (including personnel of Para-Military Forces killed in Action or Permanently Disabled in Action and Boarded Out from the Services or Ex-Servicemen and their wards will be considered for reservation. They will submit a certificate as per Appendix-F. The following categories of personnel of Territorial Army are included in the definition of Ex- Servicemen in terms of the State Govt. Letter No. 12/18/2006-GS-II dated 8-01- 2008:
 - i) Pension holders for continuous embodied service
 - ii) Persons with disability attributable to military service
 - iii) Gallantry Award Winners and
 - iv) Such recruits boarded out/released on medical grounds and granted medical/disability pension.
- 7. A candidate who applies for a reserved category will be considered first in general category on the basis of merit. In case, he/she is not selected in general category, he/she will be considered for reserved category.

The Scheduled Castes/Backward Classes candidates who get selected /admitted in Educational/Professional/Technical Institutions and Universities in open competition on the basis of their own merit, will not be counted against the quota reserved for scheduled caste/ backward classes, rather they will be treated as open competition candidates. However, such candidates shall fulfill condition of eligibility regarding age etc. as are meant for general category candidates (Memo No.13864-75 dated 24.8.2012 received from the Principal Secretary to Govt. of Haryana, Welfare of Scheduled Caste and Backward Classes Department, Chandigarh).

8. If a candidate belongs to more than one reserved category, he/she shall be required to give his/her preference at the time of filling up the admission form. Preference once given shall not be changed.

- **9.** If any seat remains vacant in sub-categories of BC (A) and BC (B), the same will be filled up through the candidates belonging to other category. For example, if any seat in BC (B) category remains vacant, the same will be filled up from BC (A) category and vice-versa.
- 10. If any seat remains vacant in sub-categories of SC and DSC, the same will be filled up through the candidates belonging to other category. For example, if any seat in SC category remains vacant, the same will be filled up from Deprived SC category and vice-versa.
- 11. Benefit of reservation will be given to all the reserved categories up to 3rd counseling according to the reservation policy given in the Prospectus. In case at the time of 3rd counseling the reserved seats of various categories remain vacant and no eligible candidates of the reserved categories are available then these vacant seats may be thrown open to Haryana General Category by the concerned Head of the Department/Director at his/her own level. In case, the seats in Haryana General Category remain vacant at the end the same will be thrown open to All India Open Category by the concerned Head of the Department/Director at his/her own level.
- **12.** Admission Criteria for EWS derived from the Government of Haryana, Notification No.22/12/2019- 1GS-III dated 25.02.2019 and even No. dated 13.03.2019 asunder:
- (a) Income & Assets Certificate issuing Authority:
 - (i) The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
 - (ii) As per instructions given in Govt. of Haryana General Administration Dept. (G-III Branch) Notification No.22/12/2019-1GS-III dated 13.03.2019, Verifying Authorities for issue of EWS Certificate shall be same as prescribed for issue of resident/income certificates as specified in instruction No. 22/28/2003-3GS-III, dated30.01.2004.
 - (iii) The prescribed format for EWS Income and Asset Certificate shall be provided at **Appendix- H1**.

(b) Criteria of Income & Assets:

- Persons who are not covered under the existing scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and BackwardClasses (Block-B) and whose family has gross annual income below Rs. 6.00 lakh (Rupees six lakh only) are to be identified as EWSs for benefit of reservation, Income shall also include income from all sources i.e.salary, agriculture, business, profession etc .for the financial year prior to the year of application.
- (ii) Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:
 - a. 5 acres of agricultural land and above;
 - **b.** Residential flat of 1000 sq. ft. and above;
 - c. Residential plot of 100 sq. yards and above in notified municipalities;
 - d. Residential plot of 200 sq. yards and above in areas other than the notified municipalities;
 - e. Total immovable assets owned are valued at Rs. one crore of more.
- (iii) The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- (iv) The term "Family" for this purpose will include the person who applies for

benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.

Note: For any other clarification, Government of Haryana, Notification No. 22/12/2019-1GS-III dated 25.02.2019 and even No. dated 13.03.2019 will be referred.

13. Criteria for EWS in **All India Category seats**:

The reservation @ 10% to Economically Weaker Sections in All India Category seats (i.e. 15% of sanctioned intake) under Centre Govt. policy would be in addition to the existing reservation. Admission Criteria for EWSs derived from the Ministry of Personnel, Public Grievances & Pensions Department of Personnel & Training, Government of India Notification No.36039/1/2019-Estt (Res) dated 31.01.2019 and the Director General Higher Education, Haryana, Panchkula vide their letter No.40395 DHE-190005/97/2020-UNP (STATE)-DHE dated 19.04.2021.

- a. Criteria of Income & Assets:
- b. Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.
- c. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - 5 acres of agricultural land and above;
 - Residential fiat of 1000 sq. ft. and above;
 - > Residential plot of 100 sq. yards and above in notified municipalities;
 - Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- d. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- e. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.
- f. Income and Asset Certificate Issuing Authority:
 - The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Appendix-H shall only be accepted as proof of candidate's claim as belonging to EWS:
 - District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/ Additional Deputy Commissioner/1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
 - Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate.
 - Revenue Officer not below the rank of Tehsildar and
 - Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
- **14.** Proforma for Economically Weaker Section of income & asset certificate issued by Government of Haryana dated 13.03.2019 as per **Appendix-H1**.

- **15.** Please Note that as per resolution no. of 22nd meeting of Academic Council held on 21/07/2020: -
 - (Viii) It was discussed and resolved by the House that, if any student strength is less than 10 in any programme, the programme may not be run and application fee to be refunded as per rules.
- **16.** If two or more candidates secure identical marks in the merit, the candidate senior in age will be given preference.
- **17.** Proforma of affidavit by the parents of the Backward Class category candidates as per **Appendix-S**.
- 18. The candidates having passed qualifying examination from the self-styled Universities/ Institutes/Boards, declared bogus/fake by the UGC and other Govt. Bodies, shall not be eligible for admission to any program in MDU. The list of such Universities/ Institutes/ Boards is available at Appendix-L. This list may vary from time to time as per notification of UGC/other Govt. bodies.
- **19.** Only those games which are recognized and adopted by the Inter-University Sports Board of India and approved by AIU will be considered for determining admission against sports seats. List of games approved by AIU is available at **Appendix-M**.

1. Admission Procedure

The admission to all the programmes will be made through ONLINE mode only. All enquiriespertaining to admission must be addressed to the concerned department/ Institute/Centre. The applicants should mention their aadhar number in the admission application form.

2. Assessment

As our pedagogy is learner friendly, adequate opportunities are provided to the learners in terms of objective assessment of learning. The university has adopted the assessment scheme as following:

External assessment 80% Internal assessment 20%

3. Credit Scheme

The university has successfully implemented the semester scheme in all its programmes. Aspart of this scheme, credits are allocated to each course and a cumulative result is derived at the end.

4. Placement Assistance

The university provides placement assistance to the meritorious students especially of the professional programme s. The companies are invited to the campus for placement.

5. Attendance

The attendance of the students in the classes is closely monitored. A student falling short of 75% attendance in any programme will be barred from appearing in the final examination. However, genuine cases will be considered according to the existing statutes.

6. Scholarships

The University offers the following scholarships to the meritorious and needy students. The eligible and interested students shall contact the Registration & Scholarship branch of the University.

- 1. Post Matric Scholarship for SC Students
- 2. Post Matric Scholarship for BC Students
- 3. Haryana State Merit Scholarship Scheme
- 4. Promotion of Science Education (POSE) Scholarship Scheme
- 5. University Research Scholarship is being provided to the Ph.D. Students of the University.
- 6. In addition to the above, the University provides financial assistance to the poor & needy students out of the "Charity Fund" of BPSMV, Khanpur Kalan.

7. Reservation & Concession

The reservation policy of the State Government of Haryana will be followed strictly for admission to all programmes.

8. Reservation in Different Programmes for the Girls of Khanpur Kalan Village

- Two seats may be reserved in every programme where the intake of student is 50. For instance graduation degree in the BPSIHL will be considered as one programme irrespective of the combination of subjects.
- If during an admission, no eligible girl candidate is available in earmarked categoryfor that year, the vacancy can be offered to the eligible girl candidate in the other reserved categories. If no candidate is available in any one of the reserved categories, the vacancy can

be offered to general category of the village, and then it will revert to the open category of seats.

9. Reservation of Seats for the Natives of Bhainswal Kalan

- Only one seat in each programme be reserved for the natives of Bhainswal Kalan who have donated land. Wherever numbers of seats are more than 50, then one seat will be increased for every block of 50. This seat will be filled up on rotation basis, starting from general category candidate and taking care of all the categories turn by turn.
- 100% concession in tuition fee in general programmes at PG level and professional programmes at UG/ PG level for those girls whose families have donated land for the university or whose land was acquired.

10. Special Seats for the Students of Jammu & Kashmir

• Two Supernumerary seats be allowed to the students of Jammu & Kashmir in every programme of the university from the academic session 2013-14 onwards.

11. Concession to the Kashmiri Migrant Students

- Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement
- Increase in intake capacity up to 5% programme wise
- Reservation of at least one seat in merit quota in technical/professional institutions
- Waiving of domicile requirements

12. Fee Concession for the University Employees

The University employees/ their wards / spouses including the wards of retired employees &wards of employees who die while in service shall be entitled for following concessions: -

- Full tuition fee concession
- Three fourth (¾) of the development fee
- 13.Weightage for the programs in which admission will be made on the basis of 10 + 2 or equivalent, Weightage of 5 marks shall be given to the holder of Certificate of Merit for NSS as per guidelines issued by the State Government.

Note: For allowing weightages to NSS, certificate should be got verified from the Programme Coordinator, NSS-.

14. For claiming any benefit under various initiatives of the State Govt., the candidate should fill up the correct Parivar Pahchan Patra (PPP ID)issued by the State Govt. of Haryana, if any and also upload a copy of the same on the portal. The benefit shall however be subject to validation of PPP ID as per due procedure.

15. Admission against Vacant Seats

- If any seat remains vacant in sub categories of BC (A) & BC (B), the same will be filled upthrough the candidates belonging to other category. For example, if any seat in BC (B)category remains vacant, the same will be filled up from BC(A) category and vice-versa.
- If the candidates in the SC/ST category are not available and the seats still remain vacant, the same may be thrown open to Haryana open category with the approval of the Vice chancellor. In case, the seats in Haryana general category remain vacant at the end, the same will be thrown open to all India open category with the permission of the Vice Chancellor. However, if the candidate of SC/ST category approaches the university thatshe could not present herself at the time of physical presence on sufficient grounds and so reserved seat has been filled up from Haryana open category candidates, the proposal for additional seat (except professional programmes in which seat can be increased only with the approval of the professional statutory councils) for that candidate, will be put up by the concerned department. This facility shall be

restricted to SC/ST students only.

16. Supernumerary Seats as per Ph.D. Ordinance

 15% supernumerary seats shall be reserved for foreign students and 01 supernumerary seat in each subject shall be reserved for teachers/employees of the university who qualify the Entrance Test.

17. Other Rules & Guidelines Relating to Fee Structure

- The fee structure includes examination fee
- Tuition fee and other dues will be payable for 6 months i.e. (Semester wise)
- The fee of any course may be changed by the University at any time, the same will be applicable on the students.

18. Refund of Fee

- A. For the programme s in which admission is granted directly by the university, refund of feewill be as following:
 - Within a week of admission ` 1,000/- will be deducted.
 - Within a month of admission 25% of the total fee deposited will be deducted.
 - Beyond one month fee will not be refunded.
- B. For the programme s in which admission is granted through Haryana State Counseling Society (HSCS) the refund of fee shall be as per the rules or guidelines of HSCS.
- C. Separate applications are to be tendered for refund of fee for programme and hostel.

19. Fee Transfer

In the event of change of programme the fee deposited will not be refunded but can be transferred internally from one department to other with the prior approval of concernedHeads.

III dated 17.03.2017, in view of the judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009 and also given in Chapter X be adhered to strictly (UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009, UGC website: <u>www.ugc.ac.in</u>& the Haryana Prohibition of Ragging in Educational Institution Ordinance 2012) :

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately. The punishment may include expulsion/suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding or withdrawing scholarships or fellowships and other benefits (ii) forfeiting campus placement opportunities or recommendations. (iii) debarring from appearing in any test or examination or other evaluation process (iv) debarring from representing the educational institution in any reasonable, national or international meet, tournament, youth festival, etc. (v) withholding results (vi) suspension or expulsion from hostel or mess (vii) cancellation of admission (viii) lodging of FIR with the local police. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear apprehension thereof in fresher or junior students or asking the students to do any act or perform something which such students will not do in the ordinary Program and which has the effect of causing or generating a sense of shame of embarrassment so as to adversely effect the physique or psyche of a fresher or a junior student or any type of abuse through electronic media or wrongful confinement, use of criminal force, assault as well as sexual offence, trespass, defamation or threat to defame will be deemed an act of ragging. Hon'ble Supreme Court of India in SPL (C) No. 24295/2004 in the matter of University of Kerala V/s Council of Principals, Colleges of Kerala and others has ordered that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain to if his/ her explanation is not found satisfactory, the authority would expel him/her from the Institution.

The applicants at the time of admission are required to give an undertaking (Appendix-J & K) against ragging.

No. Leg.15/2020 .- The following Act of the Legislature of the State of Haryana received the assent of the Governor of Haryana on the 25th March, 2020 and is hereby published for general information:-

HARYANA ACT NO. 14 OF 2020

THE HARYANA SCHEDULED CASTES (RESERVATION IN ADMISSION IN GOVERNMENT EDUCATIONAL INSTITUTIONS) ACT, 2020

AN

ACT

to provide for reservation in admission in Government educational institutions to persons belonging to the Scheduled Castes in the State of Haryana with special measures for deprived Scheduled Castes and for matters connected therewith or incidental thereto.

Be it enacted by the Legislature of the State of Haryana in the Seventy-first Year of the Republic of India as follows:-

This Act may be called the Haryana Scheduled Castes (Reservation in Admission in Short title. Government Educational Institutions) Act, 2020.

In this Act, unless the context otherwise requires,-2.

- "Annexure" means the Annexure appended to this Act; (a)
- "competent authority" means an officer appointed under section 5; (b)
- "deprived Scheduled Castes" means such Scheduled Castes as specified in (c) Annexure;
- (d) "Government educational institution" means any higher education institution established and maintained by the Government or receiving aid out of the State funds, imparting education leading to the award of a degree including a post-graduate degree and shall include Government aided technical and professional institutions;
- "Government" means the Government of the State of Haryana in the administrative (c) department;
- "prescribed" means prescribed by the rules; (f)
- "Scheduled Castes" means Scheduled Castes notified under article 341 of the (2) Constitution of India.
- Twenty per cent seats shall be reserved for the members of the Scheduled Castes Reservation. 3. (1)while making admission in Government educational institutions.
 - Fifty per cent of the twenty per cent seats reserved for Scheduled Castes for (2)admission in any Government educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the Annexure.

Where a seat set aside for candidate from deprived Scheduled Castes for admission in Government educational institutions is not filled up in any academic year due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.

Seats not to be carried forward to next year.
