1. The Chairperson/HOD/Director/Principal/Incharges of concerned departments/ regional centers/affiliated colleges & Constituent Institutions are requested to submit the system generated report of aforesaid students within two working days after the last date of from submission as per the above schedule, positively, failing which the concerned department will be held responsible for any delay.
2. In case of late admission, or late submission of exam forms due to late declaration of results of the same exam for no fault of the candidate(s), no late fee shall be charged within 15 days from the date of declaration of the result(s) of the candidate concerned. Thereafter, late fee will be charged as per schedule.
3. In the event of any last date for submission of forms without or with late fee being holiday(s) declared holiday(s)/the next working day will be deemed to be the last date.


