**Instruction to Bidders & Procedure for submission and opening of tenders:-**

1. Auction should be made on single amount lumpsum basis only.
2. Bidders are advised to visit the site in advance before submission of the tender. Tenderer shall be deemed to have full knowledge of all the relevant sample document, about site etc.
3. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specification of the work to be done and local conditions and other factors bearing on the site.
4. The bidders should have to submit the auction amount in favour of Registrar, BPSMV Khanpur Kalan in RTGS/D.D. and to send the slip/proof of depositing the amount in the University.
5. The tender accepting authority reserves the right to accept or reject any bid and to annul the process and reject all bids at any time, without assigning any reason or incurring any liability to the bidders.
6. In case the day of opening of bid happens to be holiday, the offers will be opened on the next working day. The time and place of receipt of bid and other conditions will remain unchanged.

## **TERMS AND CONDITIONS:-**

1. No bid shall be accepted in the name of any other person in case of firms etc. unless the name of all the persons making the bid is given with complete specification of shares and the person making the bid produces a valid legal power of attorney authorizing him to bid on their behalf and also copy of PAN card of the applicant.
2. The committee consisted by the competent authority shall reserve to itself the right to accept the bid subject to the approval of the competent authority or reject any bid without assigning any reason.
3. The work will be done by the bidder at his own level & cost and the site will be cleared & leveled by him in all respect upto the satisfaction of committee.
4. Safety Equipment's will be provided by the bidders at the time of cutting of trees and bidder will be responsible of any misshaping at site.

## **PAYMENT TERMS:-**

1. In case the successful/highest bidder fails to deposit the said amount as specified below, his bid shall stand rejected and the bid security deposited by him for participation in the tender shall stand forfeited in favour of BPSMV, Khanpur Kalan.
2. The bid security/EMD @ 5% will be deposit with the bid in the form of D.D in favour of Registrar, BPSMV Khanpur Kalan without bid security the bid will not be consider.
3. After acceptance of the bid, the successful bidder will further be required to deposit 100% of the quoted bid amount within 10 days of the date of issuance of Acceptance Letter and before starting the work. Bid security 5% will be refunded after satisfactory completion of work.
4. If payment not submitted with in a period of Ten days the bid security/EMD will be forfeited and no communication will be accepted in this matter.
5. The competent authority shall have the right to accept/reject any bid or withdrawal any property from auction without any reasons.
6. The allottee shall be required to undertake to abide the rule by BPSMV, Khanpur Kalan.
7. The allottee shall have to pay all general and local taxes, rates or cess imposed or assessed on the said site by the competent authority.
8. The site shall not be used for any purpose other than that for which it has been allotted. No nuisance activity shall be carried out on the site and in this campus.

## **General Terms and Conditions :-**

1. The interested bidders may visit the BPSMV, Khanpur Kalan on any working day between 9.00 am to 5.00 p.m. to inspect the Eucalyptus Trees put to auction regarding its quality, quantities and conditions etc.
2. The bidders shall quoted the prices on the letter head of firm/ price bid format and sealed envelope through Registered post/ by hand may be sent in the office of Registrar with in prescribed time limit.
3. Quoted rates should be inclusive of all taxes.
4. The bidder must submit the copy of GST registration and PAN Card with the bid.
5. All expenditure like- cutting the trees/loading/unloading & cartage charges etc. will be borne by the agency.
6. The agency will be responsible for cutting of trees as well as for complete removal of trees roots etc. from the ground.
7. If any extra trees other than Eucalyptus trees are found cutting and other material by the agency then strict action will be taken against the agency.
8. Around the Boundary wall of university campus App. 50' wide green belt has also been developed by the various types of trees and the same has been around these Eucalyptus trees. The said green belt other types of trees (Except Eucalyptus trees) has not included in the auction
9. The completion time of said work is Four Months.
10. The agency will have to follow all the rules and regulation as per the Central/State Govt.
11. The bidder will have to remove Malba/Debris/Dismantling material with in stipulated time otherwise the penalty @ 5000/- per day will be imposed till the site is made clear.
12. Gate pass will be issued from 8.00a.m. to 5.00 p.m. to exist the Eucalyptus trees from the campus.
13. If the agency required electricity, the agency will have to make arrangement at his own level for electricity connection from the university on payments basis.
14. The execution of the work will be under the supervision of the committee constituted by the University.
15. The Jurisdiction of court will be at Sonipat/Gohana.
16. If the performance of the agency is not found satisfactory at any time during the period of contract. The University reserves the right to terminate the contract without

any liability by giving 15 days notice and bid security will be forfeited.

17. As per rules, 2%TDS will have to be paid separately by the bidders.
18. The successful bidder shall also be solely responsible for all liabilities arising Towards injuries, death of person, workers engaged for felling, conversion of auctioned eucalyptus tree and shall have the absolute responsibility to pay all compensation arising out of the same.
