### NOTICE FOR DISPOSAL OF RADDI


Concerning the subject cited above, it is hereby informed that the open auction will be held for disposal of the scrap/raddi items kept in the premises of BPSMV, Khanpur Kalan, Sonipat by Open Auction on 19/12/2024 on "as is, where is" basis:


The competent raddi/scrap buyers may participate in the open auction bid process subjects to the following terms and conditions:

1. The intending bidder or his authorized representative may contact Central Library and inspect the scrap/raddi materials mentioned, at the different locations between 10:00 am to 4:00 pm from 16-12-2024 to 18-12-2024 excluding Sundays and Holidays of this University.
2. An EMD of Rs. 10,000/- (Ten Thousand Only) by Cash/DD in favour of "Registrar, BPSMV, Khanpur Kalan, Sonipat" needs to be deposited to the convener of the committee in the Central Library on 19-12-2024 upto 11:00 am and open auction at 11:00 am same day in the Central Library. The said amount will be returned on the spot to the scrap/raddi buyer, who quoted the lower prices.
3. Bidder quoting highest amount after the open auction shall be declared a successful bidder. (No further correspondence will be entertained by the University. In case of failure to accept the same or lift the material within 07 working days, the EMD amount will be forfeited).
4. The Auction of Raddi will be held under different categories: Old Newspapers, Magazines, Prospectus/Old Handbook Gatta of Information, Waste Paper and Gatta etc.
5. Successful bidder will lift the Raddi (Old Newspapers, Magazines, Pamphlets and other ephemeral materials etc.) as and when informed telephonically or through e-mail.
6. Payment of the Scrap/Raddi is to be made on the spot when lifting raddi in various Deptt./Inst./College/Branch/School/Offices etc.

7. Raddi and other materials shall be weighted on the electronic weighing machine in the presence of the committee.
8. The Raddi paper will have to be lifted from the premises offices within seven working days of receipt of intimation from this office; otherwise, the above materials will be sold at the risk and cost of the contractor.
9. If it is found the that bidder is not following the terms and conditions of payment/delivery or other conditions of the auction and also indulging in any malpractices either himself or by his agents, deputes or observes, such bidder is liable to be blacklisted. Appropriate action will be taken as per govt rules and regulations, an EMD of Rs. 10,000/- deposited will be forfeited.
10. The bidder must bear the labour and transport costs for carrying the materials. The successful bidder/buyer shall solely be responsible for movement and proper behaviour of their deputies, agents and labourers on BPSMV, Khanpur Kalan premises. If any damage is caused to the University property, the buyer is responsible for making good such damage to the satisfaction of BPSMV, Khanpur Kalan authorities.
11. The scrap buyers Bidder should a submit copy of their Pan Card and Aadhar Card with EMD amount.
12. The University Librarian/Convener/ competent authority of BPSMV reserves the right to accept/cancel the bid without further notice or assigning any reasons. Competent Authority also reserves the right to relax any of the conditions stipulated in this letter.
