This Memorandum of Understanding is made between Haryana Vishwakarma Skill University (Enacted by the Act 25 of 2016, State of Haryana) and Bhagat Phool Singh Mahila Vishwavidyalaya ((Haryana State University established by an ACT, Haryana Legislature and recognised by UGC under Section 2(f) and 12(B)).

Purpose of MOU

The purpose of the MOU is to promote mutual cooperation in educational, skill development and research activities and establish a framework for programmes of exchange and collaboration in areas of Education, Research and Skill Development for mutual benefit. This MOU would be applicable on mutual convenience and acceptable terms and conditions.

Key Areas of Cooperation:

▪ **Skill Development 6 months certificate Program:**

This will be for the students of +2 level and above of the university, polytechnic, schools and local community members. The technical expertise will be provided by the HVSU and certificate will be provided either jointly by HVSU and BPSMV or by BPSMV.

▪ **Joint Research Programme:**

Both the university/ institute shall work for joint and collaborative research and consultancy in the thrust areas of research.

▪ **Joint Skill Developments:**

Both the university/ institute shall work for exploring opportunities of developing programme and skill development initiative in the multiple areas

▪ **Joint Holding of Conference/Seminar/Workshop/ Training/Symposia etc**

Joint organization of conference/workshop/seminar/symposia/summer school/training/faculty development programme/ lectures etc to improve the exchange of knowledge and experience.

▪ **Faculty Exchange Programme**

Both the university/ institution shall work for the exchange of faculty depending on the requirement and experience for the benefit of the students and the research scholars.

▪ **Student Exchange Programme**

To encourage the inter-institutional visit of the students for their wider academic understanding and exposure and facilitate internship/placements and other similar initiatives.

▪ **Research Scholar Exchange Programme**

To encourage co-operation and interaction between inter-institution visits by the research scholars for wider academic understanding and exposure.

▪ **Exchange of Knowledge Resource**

Sharing of books, journals and teaching materials including textbooks, audio-videos, publications, reports and other teaching aids.


