The inter college migration will be confirmed after depositing the migration certificate and one year Institution fee of Rs. 67500/- (i.e. Tuition Fee + other charges) through Demand Draft in favour of Registrar, Bhagat Phool Singh Mahila Vishwavidyalaya, Khanpur Kalan, Sonipat or on the Fee counter of BPSMV (Axis Bank Branch in Teaching Block-II). After that, candidate will be eligible to take admission to continue his/her study in the Institute. The student have to pay three years fee (i.e. 675003 = Rs. 2,500/-) of the Institute to complete her BAMS Course.
