

- Eligibility criteria for Migration will be strictly as per the NEET Merit and Score achieved in NEET 2023 Examination.
- Migration will be done keeping into strict consideration of the prevailing reservation policy. If a candidate is not available in a particular category then the vacant seat will be considered as Un-Reserved.
- The preference will be given to the Residents of Haryana and the Haryana Resident certificate will be the valid documents for the verification of the same.
