NOTICE

Sub: Filling of Additional Subject Form by the Pass-out Students of B.Ed. (Two-Year) Programme opting for an Additional Pedagogy Subject.

All pass-out students of the B.Ed. (Two-Year) Programme who intend to opt for an **Additional Pedagogy Subject** are hereby informed of the following:

1. Who May Apply

Only those students who fulfil the eligibility conditions prescribed under the B.Ed. (Two-Year) Programme Ordinance for the Additional Pedagogy Subject. Students must satisfy themselves regarding their eligibility *before* submitting the form.

2. Where and When to Apply

The Additional Subject Form is to be filled in the **Department of Education, BPSMV**, from **17.08.2026 to 30.08.2026** along with the prescribed fee as per University norms. No form shall be accepted after 30.08.2026.

3. Procedure to be Followed

- Visit the Department of Education and ascertain the requirements and eligibility conditions for the Additional Pedagogy Subject of your choice.
- Obtain the Additional Subject Form from the Department.
- Complete the form in all respects and attach all documents and requisites as specified by the Department.
- Submit the completed form to the Department of Education **on or before 30.08.2026** and obtain an acknowledgement of submission.

4. Examination Requirement

As per the provisions of the B.Ed. (Two-Year) Programme Ordinance, a candidate opting for an Additional Pedagogy Subject shall be required to appear in **both the Theory and Practical components** of the Pedagogy of the Additional Subject, in accordance with the B.Ed. syllabus and evaluation scheme prescribed by the University.

5. Schedule of Examination

The Pedagogy (Theory and Practical) examinations of **Semesters I, II and III** in respect of the Additional Pedagogy Subject shall be conducted **along with the regular Third Semester B.Ed. Examination** (tentatively in November/December 2026), as per the University examination schedule.

6. IMPORTANT – PLEASE NOTE CAREFULLY

No student shall be permitted to appear in the examination of the Additional Pedagogy Subject if she has not:

- (i) Submitted the Additional Subject Form within the stipulated period of **17.08.2026 to 30.08.2026 along with the prescribed fee as per University norms;** and
- (ii) Fulfilled all the requisite conditions and formalities prescribed under the B.Ed. (Two-Year) Programme Ordinance and by the Department of Education.
- (iii) A student shall be permitted to opt for an Additional Pedagogy Subject only once after completion of the B.Ed. (Two-Year) Programme and only one Additional Pedagogy Subject/Paper may be opted for at a time.

Requests for late submission, or for relaxation of the prescribed conditions, shall not be entertained under any circumstances.

Students are therefore advised to note the above provisions carefully and to complete all requisite formalities well within the prescribed period.

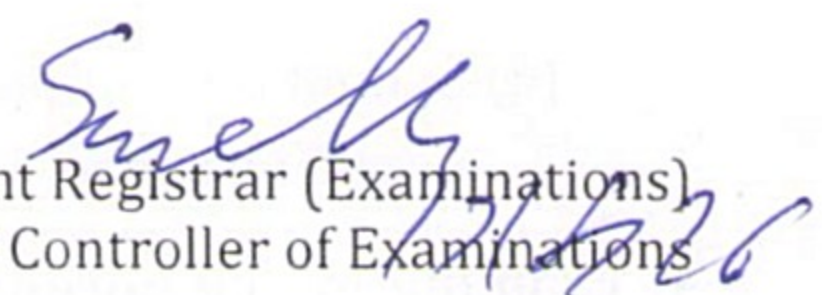
