



offered to the candidates belonging to Scheduled Caste first and in case the seats remain vacant after offering to the SC category candidates on 13.07.2026, the same will be offered to candidates belonging to HOGC.

Instructions for the Candidate

1. The candidate are required to deposit fee up to 7th July 2026 failing which their admission stands cancelled and the vacant seat will be offered to candidate next in merit although such candidates shall have right to participate in physical counseling subject to vacant seat, if any.
2. The candidate shall bring their original testimonials in support of their educational qualifications, reserve category certificate issued by the Competent Authority (if any) along with two sets of self attested copies of the above documents.
3. The Candidate shall deposit the fee in online mode through debit card or credit card as the fee shall not be accepted in cash.
